

## DOOR PICK UP / DELIVERY REQUISITION FORM

- a) agree that the provision of Inland Transportation Service may result in delay, other damages and that any such delay and/or damages shall be at our sole responsibilities and liabilities;
- b) agree to be solely responsible for all risk, loss and liability relating to our request for the Inland Transportation Service and/or for your accepting our request and to pay and/or reimburse OOCL for any freight, costs, or expenses incurred as per OOCL's standard tariffs and rates and shall indemnify OOCL and hold OOCL harmless in respect of any liability, loss, damage or expense which OOCL may sustain as a result thereof, including without limitation, any additional costs for customs, inspection by authority and/or fumigation; and
- c) to comply with all rules, laws and regulations of any national or local government and/or other authorities relating to the Goods and/or the Inland Transportation Service, including but not limited to weight limit and content and weight declaration requirements and to indemnify OOCL and hold OOCL harmless in respect of any liability, loss, damage or expenses of whatsoever nature which OOCL may sustain as a result of any non-compliance.

We understand that under no circumstance shall this request constitute a binding agreement to carry or for provision of Inland Transportation Service by such service provider. OOCL may at its sole and absolute discretion at any time and without prior notice change the arrangement listed herein or make alternate arrangement. The actual provision of Inland Transportation Service is subject to the availability of equipment of the service provider, haulage and/or other means of transport and is subject to the terms and conditions set out in OOCL's standard bill of lading, including the terms and limitations of COGSA (46 USC 1300-1315), Hague Rules or Hague Visby Rules, where appropriate.
