# Southeast Asia - Australia Services – Upgraded AAA1 & AAA2 Service Products

In meeting the changing needs of the market, OOCL is pleased to announce improvements to our Southeast Asia and Australia services by upgrading our current Australia-Asia Alliance Service 1 and 2 (AAA1 & AAA2) products in order to offer more competitive transit times and better port connections.

Highlights include:

Southbound - OOCL has considered the "Speed to Market" priorities of our import customers.

• Faster southbound transit time to Melbourne, for example:

Transit time into Melbourne	CURRENT	New AAA1
ex Singapore	14	10
ex Laem Chabang	18	13
ex Nhava Sheva	32	27
ex Felixstowe	37	33

<u>Southbound</u> – OOCL has enhanced the Australian port coverage per week for our import customers:

- AAA2 continues to call Melbourne and also add Sydney
- AAA2 / AAA1 / ASA now give OOCL 3 sailings per week into Melbourne and Sydney.
- ASA continues to offer fast transit into Brisbane
- ASA / AAA2 continues to give OOCL 2 service calls per week into Adelaide
- AAA2 continues to offer fast transit into Fremantle

<u>Northbound</u> - OOCL improves transit times for exporters ex Brisbane to South East Asia and transshipment destinations. Depending on the destination, OOCL service will be 5+ days faster than current.







### **DPW Industrial Situation**

The recent industrial unrest has led to work stoppages and delays at DPW terminals. This is causing a flow on effect with disruption at other terminals. OOCL Operations are working tirelessly with terminals and vessel operators to minimize the impact on our customers, however there will be disruption and congestion as a result.

These events and related impacts can change quickly so we do strongly encourage our customers to monitor industry news sites for updates.

## **Bangladesh Heavyweight Charge (OWC)**

OOCL will implement an Overweight Charge (OWC) for 20'GP and 20' RF container from Australia and New Zealand to Bangladesh destination at the quantum of USD150 per 20', for cargo weight 15,000 KGS or above.

Effective date 5th August 2019 based on onboard date.

Payment Term: Freight payer

#### Emergency Risk Surcharge (EMC) for UAE, Saudi Arabia and Middle East

Taking into consideration of the tensions in the Straits of Hormuz area and increasing operating & insurance costs of our services, OOCL will implement an Emergency Risk Surcharge (EMC) in order to recover the additional cost incurred, for all cargoes both Australia and New Zealand shipments to and from UAE, Saudi Arabia and Middle East with details as follows:

Southbound

Origin: UAE, Oman, Qatar, Bahrain, Saudi Arabia (except Jeddah), Kuwait and Iraq Destination: Australia and New Zealand Quantum: US\$50 per TEU Effective date: 15th July 2019 based on onboard date Payment Term: freight payer

#### Northbound

Origin: Australia and New Zealand Destination: UAE, Oman, Qatar, Bahrain, Saudi Arabia (except Jeddah), Kuwait and Iraq Quantum: US\$50/TEU Effective date: 5th August 2019 based on onboard date Payment Term: Freight payer

## **OOCL & New Markets – Our Global Network continues to Grow**

We are pleased to continue to share the news and updates of OOCL's service expansion into Africa, Caribbean and Latin America. These updates include:

#### 1) Africa

In addition to the African agencies which were set up in the 1st half of 2019 (Cote D'Ivoire; Ghana; Nigeria; Senegal) TIP March 2019 edition, OOCL has opened up new agencies as below in July 2019 and we are ready to accept cargo: -

- Angola (Port Luanda) WAF4 over Singapore
- Namibia (Port Walvis Bay) WAF3 over Singapore

#### 2) Caribbean

OOCL is also opening up agencies in the Caribbean in August 2019:-

Jamaica (Port – Kingston)

Dominican Republic (Port – Caucedo) in August 2019

#### 3) Latin America

In July 2019 OOCL added a new South America East Coast loop, TLA2, which will provide an extensive port coverage of Brazil.

• TLA2 - Ningbo - Shekou - Singapore - Sepetiba, BR - Santos, BR - Paranagua, BR - Itapoa, BR - Navegantes, BR - Itajai, BR - Santos, BR - Singapore

<u>NOTE</u>: Ecuador – Export and Import Terminal Handling (THC/THD) will increase from USD145/container to USD175/container effective 1st August 2019.

## Inbound Operation Restrictions during 2019 Chinese National Holiday in South China

During the forthcoming 2019 Chinese National Holiday, there will be operation restrictions for import shipments in South China including Guangdong, Guangxi, Hainan, Yunnan and Guizhou) as following:

All inbound Awkward cargo (out of Gauge) shipments will be prohibited	September 23 to October 08	For some ports in Hainan / Guangxi and Zhanjiang port in Guangdong
	September 23 to October 05	For the ports in "Pearl River Delta" ports including but not limited to Huangpu / Guangzhou / Foshan / Sanshui / Zhongshan / Zhuhai/ Jiangmen / Dongguan/Huizhou /Shantou
Feeder service will be suspended (subject to terminal operation at final destination	September 23 to October 08	Hainan/ Guangxi / Yunnan / Guizhou and "Pearl River Delta" ports including but not limited to Huangpu / Guangzhou / Foshan / Sanshui / Zhongshan / Zhuhai / Jiangmen / Dongguan / Huizhou / Shantou / Zhanjiang

Any demurrage/ detention incurred at transshipment port will be on account of cargo due to such restrictions during the aforesaid period. Please kindly arrange your shipment well in advance.

## Prohibition on Import of Solid Plastic Waste in India effective 06 March 2019

The Government of India (Ministry of Environment, Forest and Climate Change) has amended the Hazardous Waste (Management& Transboundary Movement) Rules, 2016 on 06 March 2019 and prohibited the import of solid plastic waste into India.
