

OOCL Terms & Conditions for Pre- and On-carriages

1. All freight offers are non-binding and subject to equipment and transport availability until receipt of a confirmed booking note.
2. Terms & conditions can be revised at any time, OOCL giving at least one month pre-notice of relevant amendments.
3. Toll charges are included in base rates.
4. OOCL reserves the right to implement fuel floater and any other Energy surcharges in case costs increase significantly.
- 4a. Truck: Fuel charges are not included in base rates and will be charged under excluded Fuel surcharge (IFL/IFD). Fuel floater on monthly basis can be found here <https://www.bgl-ev.de/images/downloads/dieselpreisinformation.pdf>**

- 4b. Barge: BAF and Fuel charges are included in base rates.**
- 4c. Rail: Energy and Fuel charges are included in base rates.**
- 5. Congestion surcharge under ICO/ICS is not included for transport modes truck, rail and barge.**
6. Carriers haulage deliveries in Switzerland and Poland via GERMAN ports / deliveries in Austria and Germany via any port include 2 hours free waiting time for stuffing and stripping. In Czech Republic and Slovakia, the free time is about 4 hours. For Czech Republic and Slovakia free waiting time will be reduced to 3 hours as from April 1st 2024.
Potential waiting times for any customs or other purposes will be deducted from before mentioned granted free waiting times.
7. We do not accept fixed delivery dates for any carrier's haulage booking. Additionally, no labor cost for stuffing and unloading or similar costs are accepted unless agreed and confirmed in writing in advance.
8. The definition of waiting time and delay is as follows:
 - Any delay of up to 15 minutes is not considered as such. Waiting time will be charged as per tariff after free time expired.
 - Once loading/stripping is not feasible due to delay, it is customer's obligation to communicate this immediately.
 - In case proof of delivery is required, OOCL will provide the proof and charge additional costs to the client. Digital (without signature) delivery/pickup notes (CMR) need to be accepted by the customer.
 - Loading in:
Switzerland & Poland via German ports / Austria & Germany via any port: 2 hrs free
Hungary, Czech Republic, Slovakia via any port: 3 hrs free
(Bremen and Hamburg city limits 0.5 hrs only)
9. Maximum payload for all motor transportation is 24.7/22.5 tons per 20ft/40ft. For combined transport, the max. payload is 28.7/27 tons per 20ft/40ft. The max. payload for live reefer is lower due to heavier chassis. The mentioned weight limitations are for German deliveries only, for other countries lower weight limits may apply.
10. Waste and scrap deliveries always require a separate request and quotation.
11. Any demurrage charges resulting from delayed customer's requests (e.g., but not only incomplete delivery instructions) or from delay which are beyond shipper's control (e.g., but not only act of God, strike) must be paid by the party requesting haulage arrangements.
Despite the best possible plan at time of order acceptance, DD2in1 and Quay Rent charges may occur at any mainline port due to reasons beyond OOCL control. Those charges could be invoiced to booking party accordingly.
- 12a. Export: Any transport job order (truck, barge, rail) cancellation with less than 48 hours (2 working days) notice before agreed appointment date may result in waste trip cost and other additional cost which we will charge as disbursed, this affects also round-trip containers with cancellation less than 24 hours before planned empty pick up.
- 12b. Import: Any cancellation with less than 48 hours (2 working days) notice before the agreed appointment date may result in waste trip cost and other additional costs which we will charge as disbursed. It is the responsibility of the purchaser (customer) to submit all required documents and information and finish inbound customs arrangements before 10.00 a.m. the day before the date of dispatch for combined Barge/Truck and rail/truck transport and 48hrs (2 working days) before appointment date for

truck transportation. Otherwise OOCL reserves the right to charge for a waste trip and other additional costs if for such a reason transport cannot be done as planned.

13. Application of B-/Z-/BHT/WHT-Numbers for outbound shipments via Hamburg, Bremerhaven or Wilhelmshaven must be supplied / applied by the shipper timely. The same applies for EX-1 handling via the ports of Antwerp and Rotterdam. The shipper is obliged to arrange export customs procedures before the container arrives at the Port of Loading in case terminal rules require this.

14. Shipments of restitution goods (T-5, BVD, AKM etc.) must be advised to OOCL during booking submission. Information about full details of document flows is mandatory. OOCL does not accept any liability for lost documents. OOCL will also decline any liability for outbound paper clearance at any mainline port. (T1/EX1 papers)

15. The customer is responsible for supplying all required customs documents or advising the valid customs status in time before loading.

16. Loading references and necessary documentation which are needed for loading must be submitted unsolicited min. 24 hours before delivery date. Otherwise, transport cannot be guaranteed as planned and any related costs (i.e., not limited to mere transport costs) will have to be borne by the customer.

17. The carrier does not accept any liability for cargo claims in connection with non-operated inland transport of reefer equipment on customer request, the risk is entirely with the booking party requesting the non-operated inland move.

18. All pre- and on-carriages are subject to OOCL's general business terms and conditions (B/L terms and conditions) respectively subject to German legislation as specified in the German commercial code (HGB).

19. Restrictions:

Cargo values ≥ 150.000 , - Euro shall be advised to carrier in writing prior to cargo door collection, latest in line with placement of booking notice to allow verification of sufficient transport insurance coverage beforehand. In case of non-conformance, carrier rejects all liability. The same applies for alcoholic beverages, tobacco; cigarettes and cigars restricted for transport – transport options/costs must be pre-checked for transport in C/H.

20. In case of cost increases due to external factors, beyond the control of OOCL we reserve the right to forward such additional costs to our customers.

21. In the event of official instructions due to pandemic regulations, OOCL will comply with these, and any additional costs are to be borne by the client.

22. Additional surcharges must be claimed within 3 working days. Cost reductions or claims will not be accepted after 3 working days.

23. Freight offers do not include additional costs such as customs clearance, customs documentation, any multi-stops, dangerous goods surcharge/label, tilt- or side loader - chassis, cooling-chassis, Gen-Set, HS-seals, high-/low tide surcharge, etc.
