UNAUDITED QUARTERLY OPERATIONAL UPDATE FOR THE THIRD QUARTER ENDED 30TH SEPTEMBER 2007

The Board of Directors (the "Board") of Orient Overseas (International) Limited (the "Company") has adopted a policy of announcing unaudited operational updates for Orient Overseas Container Line ("OOCL") on a quarterly basis. This announcement sets out the unaudited operational update for OOCL for the third quarter of 2007 (ended 30th September 2007). The comparative figures for the third quarter of 2006 (ended 30th September 2006) are also disclosed in this announcement.

For the third quarter of 2007 (ended 30th September 2007), total volumes were 20.5% ahead of the same period last year. Total revenues increased by 26.9% to US Dollars 1,422.4 million. The overall load factor was 5.9% down from last year with a 29.7% increase in loadable capacity as scheduled newbuildings were delivered and deployed. Overall average revenue per teu increased by 5.3% compared with the same period last year.

For the first nine months of 2007 (ended 30th September 2007), total volumes increased by 19.4% over the same period last year and total revenue recorded a 19.1% increase. The overall load factor was 2.7% lower than the corresponding period of 2006 with an increase of 23.3% in loadable capacity during the first nine months of this year. Overall average revenue per teu decreased by 0.3% compared with the same period last year.
