Export Shipment – Payment & Receipt Process

1. Smart Invoice System - SMARTINV (Online system)
 - Submit the required documents including deposit slip or payment evidence and withholding tax certification (if applicable) through SMARTINV.
 - The official receipt could be automatic downloaded from SMARTINV after verification.
2. At Company Counter Service (exceptional case)
 - Provide the required documents including deposit slip or payment evidence and withholding tax certification (if applicable) at counter service.
 - Cashier will issue the official receipt at the counter service.

Note: Export Documents Release Export documents (BL) will be uploaded to the MOC / IQAX system only after full payment has been received and the original withholding tax certificate has been submitted to the Company.
