### **EU Import Control System 2 (ICS2)**

Effective November 18, 2024, OOCL has begun filing Entry Summary Declarations (ENS) into the new Import Control System 2 (ICS2) for all shipments transshipped or destined to European Union (EU) countries, plus Norway, Switzerland and Northern Ireland.

# ICS2 Import Control System 2

### Information required within your Shipping Instructions (SI):

- Straight Bill of Lading (no House BL): Buyer and seller information is required if shipment is destined to EU, Norway, Switzerland and Nothern Ireland.
  - a. If OOCL is filing the buyer and seller on behalf of the customer, please provide the following:
    - i. Company name, type of person, P.O. BOX or street number, street name, city name, country name, postal code.
  - b. If the buyer and seller are the same as the shipper and consignee respectively, then please indicate this information on the SI.
  - c. If the buyer and seller information is directly being provided to the EU customs as self-filer, please provide the supplementary declarant EORI number.

### Master Bill of Lading with House BL:

- a. Prior to December 4, 2024, OOCL is unable to submit House BL. However, customer will be required to provide the supplementary declarant EORI number (this is the number of the entity that will start submitting the house BL within the HBL implementation window from December 4, 2024 to April 1, 2025).
- b. After December 4, 2024, for those who prefer OOCL to file house bill information on their behalf, additional information will be required and more details to come.

#### Other information required:

- a. A complete and accurate cargo description.
- b. 6-digit Harmonized System (HS) code for each cargo description.
- c. The Economic Operators Registration and Identification (EORI) number of the consignee established in the EU (if available).
- d. For dangerous goods only: Customs Union and Statistics Number (CUS code) for harmless and dangerous goods(DG) chemicals if applicable, as maintained in the European Customs Inventory of Chemical Substances (ECICS).

#### **Documentation Validation:**

- If your shipping instructions (SI) are not received on time or missing required information outlined above, OOCL will be unable to load your shipments without a valid MRN (Movement Reference Number) from EU Customs. As a result, we will have to strictly enforce the "No MRN/ No load" policy.

Rail Billing Process and Requirements

### **Rail Billing Requirements:**

- Ensure the cargo description provided at the time of booking submission matches the trucker's paperwork to avoid potential cargo delays at the receiving rail.
- Via N2C3 Supplier Portal: Rail billing request is accepted **1 day prior** to OOCL's Demurrage Free Receiving Date (DFRD).
- Via email: Rail billing request must be made at least **two business hours** prior to in-gating and no later than 16:00 CST.
  - Requests for hazardous and reefer cargo must be made at least two business hours prior to in-gating and no later than 16:00 CST, Monday-Friday only.

Note: Your driver can deliver the container to the rail terminal within 1 hour of rail billing acceptance.

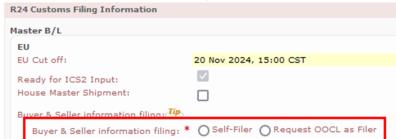
# Shipping Instructions for ICS2

Within My OOCL Center (MOC), customers now can provide Buyer & Seller information for goods shipped to or via the European Union (EU).

Log into MOC and click on "Documentation < Shipping Instructions < Instructions Submission" and fill out the required fields in the "Details" and "Container & Cargo" tabs.

### Straight BLs

Tick either the "Self-Filer" or "Request OOCL as a Filer" in the "Buyer & Seller information filing" field. Please make sure to leave the "House Master Shipment" box unticked.



If self-filer, input the "Supplementary Declarant EORI" and tick the box to accept the TOU.

If you would like OOCL to file on your behalf, tick the "Disclaimer" box and select one of the two options under the "EU24 Buyer and Seller Information" field.



### Master BL with House BL

Please tick the box next to "House Master Shipment" and then input the 'EORI number of the House Bill Issuing Party' and tick the box next to "By inputting the EORI#, I accept the TOU".













# PROTIP Supplier Portal

N2C3 Supplier Portal is a vendor portal that improves the velocity and process to manage operations and equipment. From optimized empty return locations to rail billing submissions and street turn requests, this portal has vendor solutions utilizing top tier technology. # N2C3 SUPPLIER PORTAL FEATURES



In addition to the web interface, to achieve greater efficiencies, API protocol is also available for direct integration with your ERP or TMS software.



Truckers can simply input the container number and request empty return instructions or street turn requests.



The portal will automatically display the optimal return location for each empty OOCL container(s). It will also take into consideration off hire units and special instructions.



Rail billing can be submitted by the trucker via the portal once return location is agreed.



For street turn requests, the system will automatically check booking details and provide instant approval if the requirements are met.
