


Join us at the Breakbulk Americas Conference 2024

Important Update: EU Import Control System 2 (ICS2)

Pursuant to the Release 3 of the European Union (EU)'s customs pre-arrival safety and security system called Import Control System 2 (ICS2), please note the following updates:

OOCL will commence Entry Summary Declarations (ENS) filing into ICS2 for all shipments import to or transshipped via EU countries, plus Norway, Switzerland and Northern Ireland on or after November 4, 2024.

ICS2 Data Requirements

Regarding the data element of ENS required by ICS2, please ensure that you provide complete and accurate shipping instructions (SI) before the SI cutoff closing time.

The following ENS data elements should be included:

- A complete and accurate cargo description.
- 6-digit Harmonized System (HS) code for each cargo description.
- The Economic Operators Registration and Identification (EORI) number of the consignee established in the EU, if such a number was assigned to this party, or the full address of the consignee, including the P.O. box number, postal code, sub-division code, city, and country.
- Buyer and seller information is required for place of delivery in EU member states,
 Norway, Switzerland, and Northern Ireland for the Straight Bill of Lading.
- Customs Union and Statistics Number (CUS code) for harmless and dangerous goods(DG) chemicals if applicable, as maintained in the European Customs Inventory of Chemical Substances (ECICS).
- EORI number of the supplementary declarant (Self-filer on Buyer and Seller Information or House Bill of Lading Information).

Failure to Provide Information


If your shipping instructions (SI) are not received on time, we will be unable to complete the advanced filing of customs declarations as required by the regulations.

As a result, we will have to strictly enforce the "No MRN/ No load" policy. This means that OOCL will be unable to load your shipments without a valid MRN (Movement Reference Number) from EU Customs.

For those who prefer OOCL to file house bill information on your behalf, additional information will be required starting December 2024. We shall provide you with detailed requirements in our next customer advisory.

Shipping Instructions Type of Submissions




OOCL provides multiple ways on how our customers can submit their Shipping Instructions (SI). From an online customized template to EDI options that are catered to fit each individual business needs.

MOC Shipping Instruction Submission:


Using the Shipping Instruction Submission feature allows customers to submit and amend shipping instructions from a one-stop shop within My OOCL Center. This method further allows customers to create shipping instruction templates for use with future bookings.





Via MOC Shipment Folder:

Uploading shipping instructions to the Shipment Folder is ideal for customers that utilize their own in-house shipping instruction forms.



Using the Shipment Folder feature, customers are provided proof of submission via folder time stamps as well as document status.





EDI:

- Login to My OOCL Center.
- **Establish Rate Quote** Prior to submitting your online booking via My OOCL Center, please contact NAPCRQ@oocl.com to ensure you have a valid rate for your cargo.
- **Login to MOC** Click on the "Booking" option from the main menu and then select "Booking Request."



Booking Request Module

After clicking on the "Booking Request" option, a blank booking screen will be generated. Please fill out all fields that have a "*"by it as these are mandatory.

- Insert Service Contract or Rate Reference#
- Add Party Information- Shipper/Forwarder is required.
- Cargo Nature- choose "Awkward" from the menu regardless of In-Gauge or Out-of-Gauge status. This will activate your cargo dimension fields and ensure your booking request is received by our Project Cargo booking team.
- Fill out the routing with origin and destination city.

Container Information and Cargo Dimensions

Please ensure the unit selected is in meters as OOCL does not accept awkward cargo measurements in feet. Fill out the quantity, size type, cargo weight, cargo dimensions including length, width, height and choose unit in meters. Note: We do not accept requests for "40' Flat Rack Height Adjustable."




Shipment Details Feature
