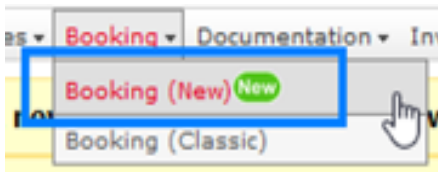
New Online Booking Form: A personalized booking experience

To access the new booking form:

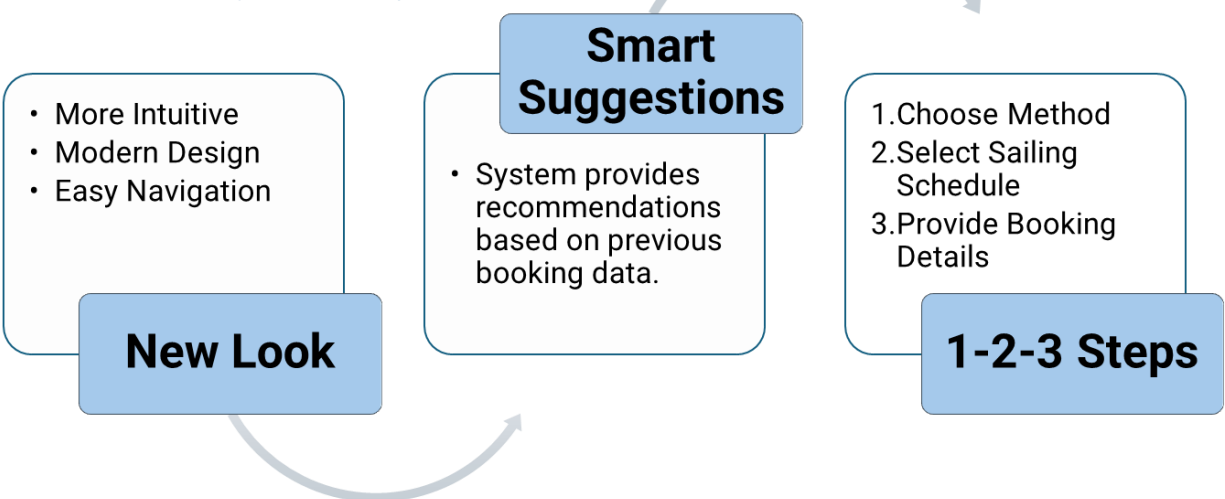
1. Login to My OOCL Center.
2. From the main menu select: Booking->Booking (New)



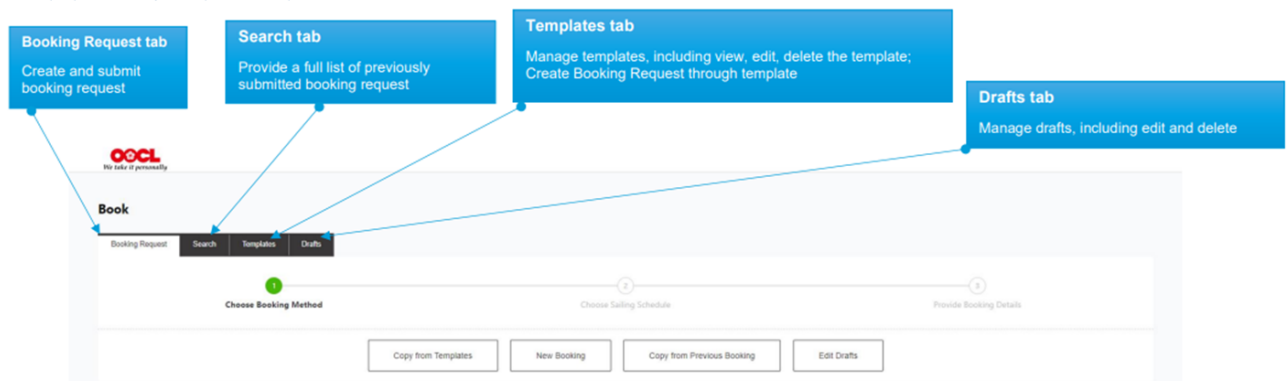

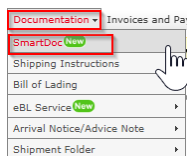
BOOKING FORM OVERVIEW



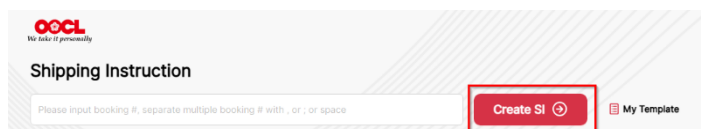
SmartDoc: Shipping Instructions Creation

SmartDoc is the the latest enhancement to our shipping instruction (SI) submission tool in My OOCL Center (MOC) platform. Combining decades of shipping expertise with advanced AI technology, SmartDoc is designed to enhance accuracy and streamline your documentation process.

- 1 Once logged into MOC go to **“Documentation”** on the menu bar and select **“SmartDoc”**. The default SI home page will populate including a search bar.



- 2 Enter the desired booking in the search bar and click the **“Create SI”** button.



- 3 On the next screen, enter the SI details in three separate tabs: **“Shipment Info and Parties”**, **“Cargo and Container”** and **“B/L Handling Instructions”**. Data for some fields will be pre-filled from the booking information. Kindly ensure that all mandatory fields (indicated with a *****) are completed before submitting your SI.

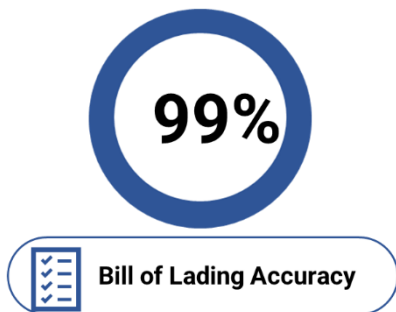
- 4 If you would like to review the SI before submitting, click the **“SI Preview”** button. The preview will show your SI details in a BL format. Additionally, you can also create a template from the SI, save as a draft, or cancel the SI. Click the **“Submit”** button once you are satisfied with your inputted data.

How can I submit Bill of Lading (BL) amendment requests?

BL amendment can be requested via MOC. Amendments may also be accepted via EDI or via the same email address as the SI submission. Email contacts can be found [here](#).

What is the turn time for processing Shipping Instructions (SI)?

Shipping instructions are processed within 2 hours of receipt during business hours. Upon completion of the Bill of Lading (BL), OOCL will provide customers with a copy so data can be reviewed for accuracy.

What is the turn time for the BL Amendments?

BL amendment requests are processed within 4 hours if received during working hours unless further clarification is needed.

When will OOCL issue the Bill of Lading?

Onboard Vessel BLs are released within 24 hours of vessel sailing, while Received for Shipment or Onboard Rail BLs are released within 24 hours after the proforma BL is completed and delivered.

What do I do if my letter of credit requires a shipping certificate?

Upon request, our Documentation team can prepare vessel certificates to satisfy Letter of Credit requirements. The request can be submitted via the respective email address [here](#). Certificates are issued at the time when cargo is confirmed on board as it may include vessel related information.

Does OOCL offer an eBL solution?

Electronic bills of lading (eBL) is an alternative method to improve the efficiency and security of paper original bills of lading. For more information, visit our [site](#).

- 1 To access the **Control Tower** on your MOC home page, simply click the Control Tower tab on the far right of your tool bar.
- 2 Selecting "**Container Overview**" will provide an overview of all active containers as well as their status and milestones event time-stamp.

- 3 By clicking a container related booking/bill of lading hyperlink you can view further information on the container as well as the status of documents by clicking "**Document Status**". The "Document Status" tab will list the required documents and if it is pending submission, the red "Submit" button will be displayed. Users will also see document cutoff dates as well as document statuses.
