## **Rail Pickup Number**



The rail pickup number ensures that only authorized parties can retrieve a container from the rail ramp. The customer is provided the pick up number after certain criteria have been met for the release of cargo.

At OOCL, the easiest way to obtain the pick up number is via our shipment management tool— My OOCL Center (MOC). In order to have access to this number online, you must be:

- ✓ A legal party of the Bill of Lading (consignee or notify party).
- ✓ All charges are paid.
- ✓ The Original Bill of Lading (OBL) is cleared.
- ✓ The Customs status is released, rceeived in OOCL's system, and there are no agency holds.




## Obtaining a Bill of Lading Copy via MOC's Shipment Folder



My OOCL Center (MOC) offers a centralized repository called "Shipment Folder" that allows shipment parties at destination to download and print documents such as the Bills of Lading copies, Invoices and Arrival Notices.



# Detention and Demurrage Calculator

My OOCL Center recently launched a detention and demurrage (DD) calculator for import shipments. To access this feature, the following requirements are needed:

- You must access the DD calculator through the Tracking module and search by <u>BL Number</u> only
- You must be a party to the BL.
- The <u>Last Free Day (LFD)</u> information needs to be available.






Input the desired bill of lading number and click on the "Search" button. Then click on the "Detention and Demurrage" tab.

To start utilizing the DD calculator feature, click on the calculator icon within the Inbound Demurrage or Inbound Detention "Last free date" fields. Click on the calendar icon select the desired pickup date and then click the "Calculate" button. The estimated DD charges will appear based on the date selected. Cargo Tracking

My OOCL Center allows you to view the demurrage and detention Last Free Day (LFD) for import containers on your bills of lading using My OOCL Center or OOCL's public website.




#### **Log into MOC**
