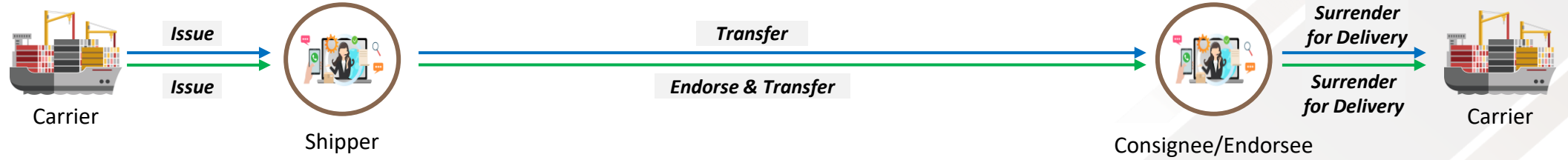

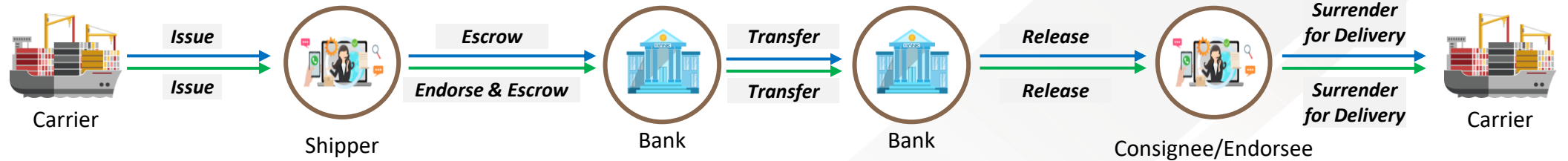

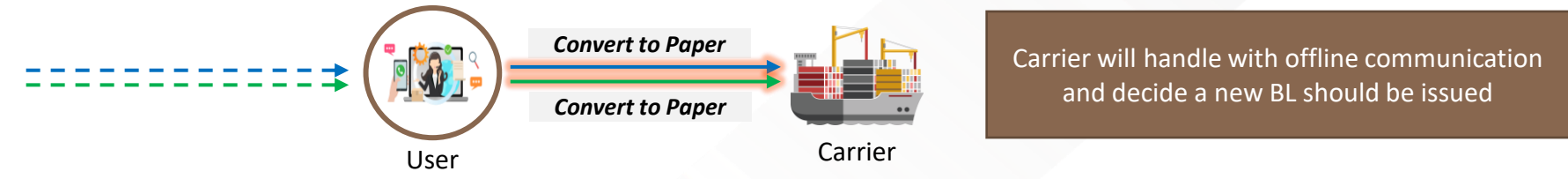

# Introduction on IQAX eBL

## Type of BL and User Role



### Straight BL

- The consignee is named when the bill is issued and cannot later be changed
- Not possible for the shipper or the consignee to transfer legal title and ownership of the cargo to a third party by means of endorsing the bill
- The carrier is obliged to deliver the cargo to the consignee specified in the consignee box on the BL

### Type of BL



### Negotiable BL

- Either needs to state 'to order' or 'to order of [name of the party]' in the consignee box
- Legal title to the cargo can pass from the original bill of lading holder to a third party by means of endorsing the BL

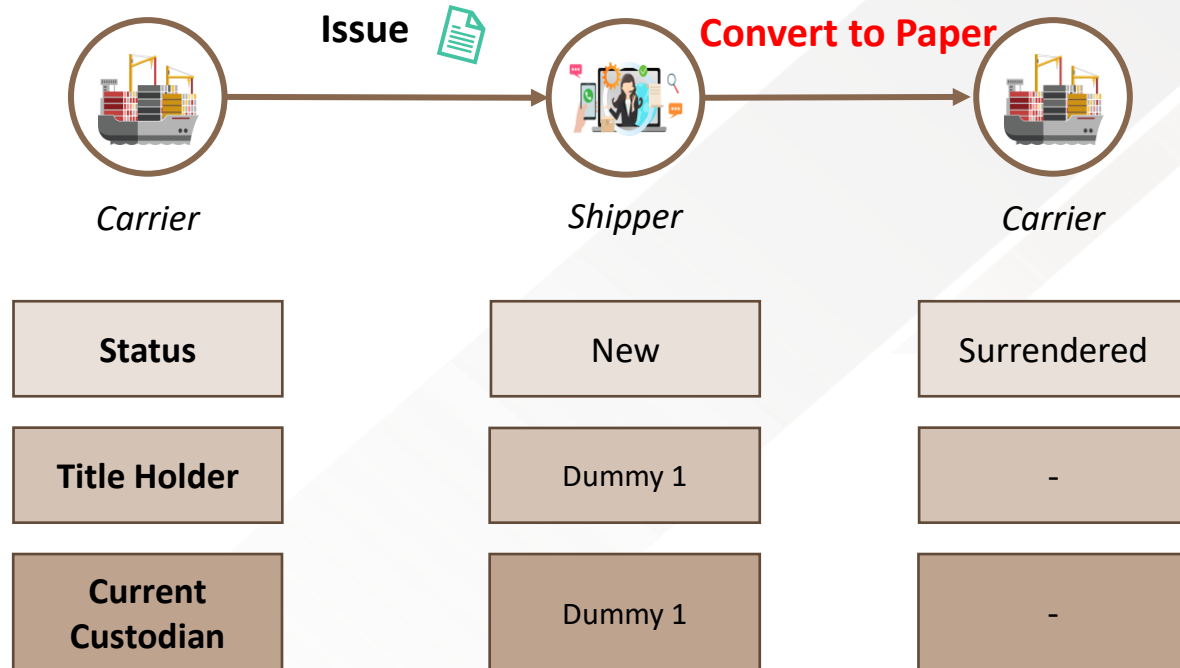
